DEADLINE: Deadline for accepting applications is Friday November 16, 2006

Spots will be filled on a first come, first serve basis. To ensure participation, please return application as soon as possible.

SPACE FEE: Flat fee of \$50.00 (For Coweta Chamber Members) for each 10' x 10' space.
Flat fee of \$75.00 (For Non Coweta Chamber Members) for each 10' x 10' space.
Flat fee of \$150.00 to join the Coweta Chamber & have a 10' x 10' space.

ELECTRICITY: You will have access to one 110 outlet in the Family Life Center, however, you are welcome to bring battery operated lighting for your display.

SHARING SPACE: You may share one (1) space with approval of the Coweta Christmas Celebration '07 Coordinator

REFUNDS: NO refunds given for cancellations.

SET-UP: Set up will begin Friday, November 30th from 10 a.m. - 10 p.m. Exhibitors must furnish their own tables, chairs, easels, and any other display equipment. Coweta Christmas Celebration '06 does not have any of these items to rent. We simply provide booth space.

HOURS OF OPERATION: SATURDAY, DECEMBER 1st from 8am to 7pm

SALES TAX: Each vendor is responsible for his/her own sales tax.

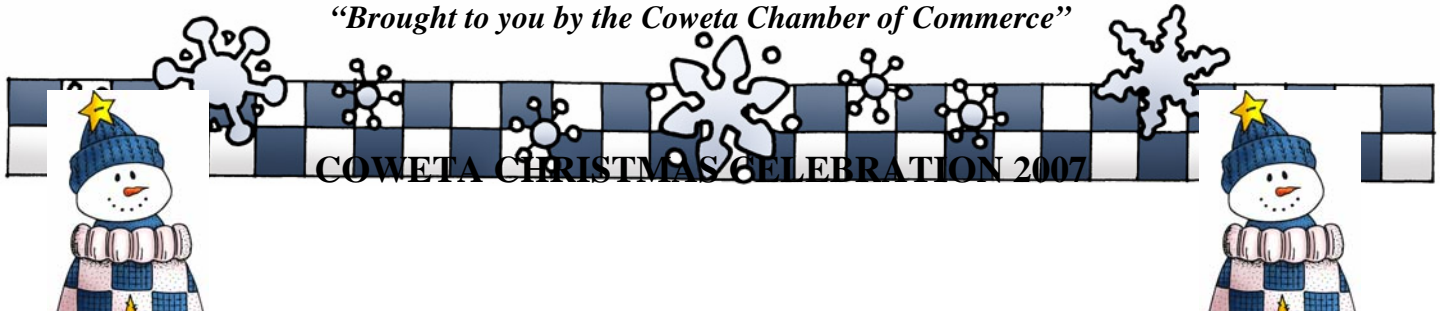
PROPER CLEAN UP: It is expected during and after the **COWETA CHRISTMAS CELEBRATION '07** you leave your assigned space(s) as you found it.
